Rules and Regulations for the Happening "Ask the Pope"

The Happening "Ask the Pope" is an attempt to fathom the desire of the human heart. Every person seeks to discover within himself what is fundamental in his human nature. This quest for the truth within the human heart also involves the proposals of the Church.

Here is a glossary of terms and their meanings in the context of this Happening:

- 'happening' is the event and presentation called "Ask the Pope";
- 'participant' is a person taking part in the Happening;
- 'participant of World Youth Day' is a person who has bought or has had a pilgrim package, a volunteer package or a ticket to that event;
- 'Organizer' is the director of the Happening who is responsible for the operation of the exhibit including issues of public safety and information;
- 'The Palace of Art' is the Palace of Fine arts in Krakow located at Plac Szczepanski #4, 31-011 Krakow.

§ 1

- 1. The "Ask the Pope" event takes place during World Youth Day celebrations, from 20 to 27 July 2016.
- 2. It is located in the above mentioned Palace of Fine Arts on Plac Szczepanski.
- 3. This event is organized by Tracce of Communion and Liberation located in St. Anthony Street 34, Wroclaw, KRS 0000353689.
- 4. Cardinal S. Dziwisz of Krakow and the Movement of Communion and Liberation in Poland are the patrons of the Happening.
- 5. The aim of the Happening is to promote the New Evangelization to both the formal participants of World Youth Day and the residents and visitors of Krakow.
- 6. All participants are kindly requested to comply with the following directives for the purpose of making the Happening a safe and rewarding experience.
- 7. Please refer to the instructions available at the Palace of Fine Arts or online at http://www.askthepope2016.com/.
- 8. The Organizer has the right to change and amend the regulations regarding the administration of the Happening without prior notice.

- 1. Admission to the grounds is free to all including accompanied minors.
- 2. Entrance to the exhibits in the Palace of Fine Arts is free to all formal participants of World Youth Day while other visitors will need to purchase a ticket.
- 3. Visitors are responsible for any damage caused by irresponsible behavior by any accompanied minors.
- 4. The Organizer is not liable for any damage caused by visitors and participants to the Happening.
- 5. Due to limited capacity, priority of visitation will go to registered participants of World Youth Day who have made advance reservations to visit the event and based upon their language of preference.
- 6. Those who have not made advance reservations will be served on a first come first serve basis.
- 7. Multiple visits are allowed based upon space availability.
- 8. Visitors are requested to maintain a quiet atmosphere in order to allow concentration and full participation in the event.
- 9. Participants may use cameras, cell phone cameras and other recording devices at the event.
- 10. People with disabilities are welcome, however, the Palace of Fine Arts is not wheelchair or handicap accessible.

§ 3

- 1. Participants to the Happening mustn't bring:
 - knives, sharp/dangerous implements or tools, weapons,
 - explosive or flammable products,
 - hazardous materials,
 - alcoholic beverages,
 - narcotics / psychotropic drugs or substances causing similar effects.
- 2. No commercial activities may take place at the venue.
- 3. There is to be no consumption of food or beverages.
- 4. No dogs or animals are allowed.
- 5. It is forbidden to damage, destroy or deface any objects, facilities, equipment or props located in or about the Palace of Fine Arts.

- 6. The Organizer or agents operating on his behalf may exclude or expel any visitor who does not abide by the above stated rules or who behaves in a disorderly or disruptive manner which may cause a threat to public order and security.
- 7. Each participant bears full responsibility of both financial and criminal penalties for any damage or behavior detrimental to the public good.

§ 4

- 1. The Organizer seeks to aid the safety and well-being of all visitors by providing guides, security and first aid personnel.
- 2. This staff will be made aware of fire exit and fire suppression systems and be connected to fire/rescue and police.
- 3. In health and safety emergencies all participants are to follow the directions of professional emergency and public safety officials. Where appropriate additional Law Enforcement and Organizational directives for World Youth Day will be implemented.

§ 5

- 1. Law enforcement and authorized personnel have the right to establish the identity of any participant and if deemed necessary or prudent may search individuals, luggage, clothing and personal possessions of any participant for harmful or potentially dangerous items or substances. Disruptive, provocative or peculiar behavior may also warrant search.
- 2. People may be requested to leave the event. In the case of a direct threat to life, health, or property they may be subject to Law Enforcement officials.
- 3. The above mentioned rules are for the public health, safety and security of all people involved in and around the World Youth Day 2016 Happening.
- 4. Thank you for your cooperation in making this the best World Youth Day for everyone.

ORGANIZER
